GENERAL POLICY

Coral Canyon Elementary values strong collaboration with parents, families, and the wider school community. We ensure parent and family input through our Annual Title I Meeting, regular School Community Council meetings, and monthly PTO meetings.

POLICY INVOLVEMENT

Annual Meeting

Each fall, Coral Canyon Elementary hosts an Annual Title I Meeting to provide an overview of Title I services, funding allocations, student performance in literacy and mathematics, and available intervention and enrichment opportunities. Communication tools and strategies for staying connected with the school are also shared.

Parent-teacher conferences are held twice a year to discuss student progress. Parents can schedule individual meetings with teachers using our online. Recognizing the diverse needs of families, we offer flexible meeting times throughout the year. Conferences can be arranged before or after school upon request.

Coral Canyon Elementary actively seeks parent input through monthly PTO meetings and School Community Council sessions. We also analyze feedback from our annual school-wide survey to continuously improve how we inform, communicate, and collaborate with families.

BUILDING CAPACITY FOR FAMILY ENGAGEMENT

To strengthen family-school partnerships and support student success, Coral Canyon Elementary will:

- Share information about Utah Core Standards, state and local assessments, and strategies for monitoring academic and behavioral progress at least three times each year, including during parent-teacher conferences in November and February.
- Provide parents with materials, resources, and training opportunities designed to enhance their ability to support student learning at home, including literacy events, technology workshops, and grade-level family activities.
- Offer professional development for teachers, administrators, and support staff focused on the value of family engagement and strategies for building strong partnerships with parents.
- Coordinate parent involvement initiatives with other federal, state, and local programs.
 Our parent liaison, behavior support staff, and school social worker collaborate to increase family participation and offer support services throughout the year.
