## **Parent-School Compact:**

Mr. Nelson showed compact to parents. These were handed out at SEPs in August. The only change from last year is changing the mission statement from "Racing to Success" to "Learning Today; Building Tomorrow". However, these brochures still have the old mission statement on it because they were already printed. The compact discusses responsibilities for the school, the parents, and the students. The compact also explains Title I funds and what that means.

## **Schoolwide Plan:**

Each grade level creates their own CSIP (Comprehensive School Improvement Plan) along with their GVCs (Guaranteed Viable Curriculum based on the needs of their students.

**2015-2016 SAGE and DIBELS Results:**

- DIBELS are given in grade K-3, three times a year
- Every grade made growth in DIBELS last year
- 3<sup>rd</sup> grade made at or above district and state percentages in SAGE
- Last year Coral Canyon Elementary was a B school, we are now a D school according to state report card.
- State grade is based on DIBEL and SAGE scores , formulated with proficiency and growth results
- If parents have concerns/questions with SAGE, they should contact their legislature.
- School grade will become public on September 15.

**Learning Walks:**

We would like to invite parents, PTA and members of the community to visit our classrooms and see how funds from Community Council are benefiting our school. We would like to create Learning Walks for this purpose. Plan 1<sup>st</sup> learning walk for the end of November. No small children should come on Learning Walk.

**Internet Safety & Digital Citizenship:**

Safe Technology and Digital Citizenship information sheets were passed out. The school has a series of question that need to be answered on how the school is addressing the issues of technology in the school. Not all the questions have been answered but the school is working towards answering them all to ensure that technological best practices are taking place. Will discuss at next meeting.

**Overview of Trust Lands Plan:**

Two goals

1. Students will gain knowledge with STREAM learning and activities. Budget of \$1,000
2. We will increase the number of students proficient in Dibels by 5% in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> grades. Coral Canyon Elementary will increase the number of students proficient on the SAGE Language Arts and Writing assessment by 5% in 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> grades. Budget of \$36,460
